



ORGANIZATIONAL TIPS

- Allow a minimum of 8 – 10 months for the whole procedure given optimal planning.
- Study for the theory test and plan the driving lessons and the tests well in advance.
- We will notify you when your application has been approved by the KVR. Only then can you book the theory test via our office approximately two weeks before you plan to give it.
- Having passed the theory test you can book the practical test together with your driving instructor.
- Test fees have to be paid to the driving school one week in advance.
- Bring your passport for both tests and any glasses/contact lenses for the driving test and the classes.

- valid passport with photo and signature
- recent biometric passport photo
- eye test certificate (e.g. optical store, eye doctor)
- certificate for "Immediate Life-Saving Measures/First Aid" see: www.notfallmedizin.de

- approx. 45,- € for fees

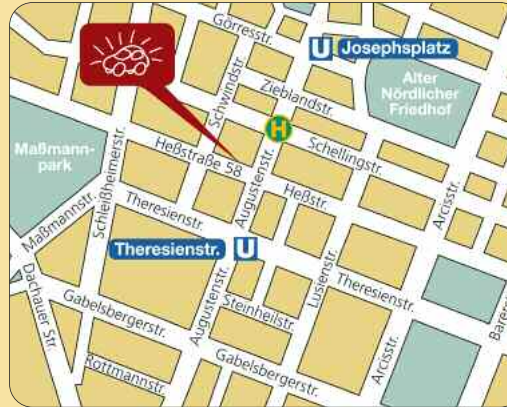

DRIVER'S LICENSE CLASS B

Christine Timmer Driving School prepares you competently and in a sensitive way for the theory and practical tests for your German driver's license class B:

- Theory lessons are given on three weekends, timetable and dates on request and online. We supply the official questions for the theory test in many different languages. Study books are available in German, English, Russian, and Turkish.
- In the car you practice all relevant traffic situations and driving maneuvers until you can handle the car and drive safely in standard situations.
- Mandatory are:
 - 14 x 90 min. theory lessons;
 - driving lessons until you are fit for the test and 12 x 45 min. so called special lessons (5 x 45 min. country road, 4 x 45 min. autobahn and 3 x 45 min. in the dark)

In spite of an otherwise good performance the test is failed and should be ended in case of severe misbehavior as the following:

- endangering or damage
- gross disregarding of a priority or preference rule
- disregarding of a red light or a police officer signaling stop
- disregarding the traffic signs
 - STOP
 - No Entry
 - any prohibition signs without a supplementary sign like "residents only"
- disregarding other prohibitions causing a possible danger
- violating a "no overtaking" sign
- passing a school or public bus at a bus stop with hazard warning lights at a speed of more than 20 km/h
- final positioning to turn left in the opposite lane
- lane changes without traffic observation
- missing reaction to children, persons in need of help or elderly people

Keep going in the 45 min. test, even if you think you made a mistake. According to the law rules should be interpreted generously; good performance has to be considered.

All the best for the test and: KEEP COOL!

A test can furthermore be failed when different mistakes occur repeatedly or frequently such as:

- insufficient traffic observation
- unadjusted speed
- passing a school or public bus at a bus stop with hazard warning lights with more than walking speed, but not more than 20 km/h
- keeping an incorrect distance
- missing readiness to brake
- disregarding the obligation to use the right lane
- long hesitation at intersections and T-junctions
- wrong positioning or failure to get into lane in one-way streets
- wrong signal or failure to signal
- faulty or missing usage of the brakes
- faulty handling of the car
- mistakes in an economical and environmentally conscious driving style
